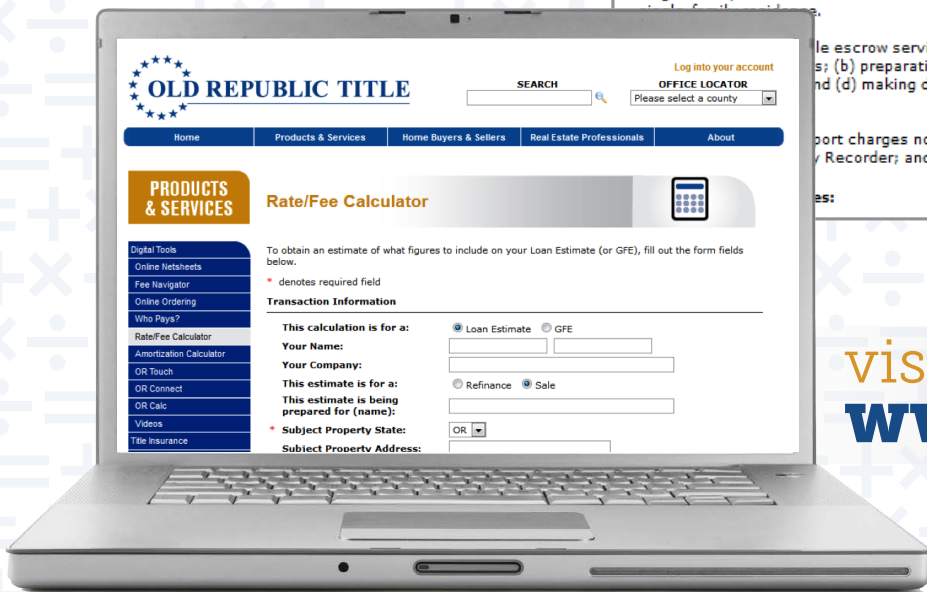


Digital Tools For Your Convenience! Loan Estimate (LE) Calculator
